- 1.1. Empanelment of Contractors for Branches, ATMs and Offices of Andhra Pradesh Grameena Bank under following categories
  - 1.1.1. Interior furnishing works at Branches, ATMs and offices.
  - 1.1.2. Carpenter works including Branch Counters, BM Cabin, Cash Cabin and any other carpenter works.
  - 1.1.3. Electrical works including repairs, Earthing, Network cabling etc.
  - 1.1.4. Architectural services for renovation of Branches/Offices, interior furnishing, electrical works/LAN cabling, air-conditioning, fire-suppression and detection system, structural engineering and designing works for Branches/Offices.
  - 1.1.5. Printing & Stationery works
- 1.2. Andhra Pradesh Grameena Bank, Head office invites sealed application forms (Technical bids) from reputed contractors having not less than 2 years of experience of the work for which empanelment is sought in above mentioned categories. The bidders should fulfill all mandatory conditions/requirements mentioned in this tender document.
- 1.3. Andhra Pradesh Grameena Bank operates across all 26 districts of Andhra Pradesh, with a robust network of 1,351 branches and 23 Regional Offices, 178 ATMS, Head Office at Guntur. The empaneled contractors are expected to offer their services in any of the Branches/offices of the Bank as may be required. Bank has the right to create a cluster of Regions/Branches where the contractor shall have to offer services depending on the place where the contractor are based.
- 1.4. Separate Application forms along with prescribed tender fee is to be submitted by the vendor for empanelment under each category. If the vendor submits more than one application in single bid or does not submit tender fee for each category, the bid will be summarily rejected. e.g. vendor applying for Interior Furnishing & Carpenter Works, Electrical & LAN works, Architectural Services and Printing & Stationery works has to submit Four different applications in Four separate envelops with separate tender fee. The contractor should clearly mention the name of work for which empanelment is sought, on the envelope itself.

  - 2. RFP means this "Request for Proposal Documents"
  - 3. Recipient, Respondent, Bidder, Vendor, means "Respondent to the RFP Document".
  - 4. Tender means RFP response documents prepared by the Bidder and submitted to Andhra Pradesh Grameena Bank, Head Office, Guntur.
  - 5. Client, Client means organization for which the contractor has completed any work.

#### 2. TENDER NOTICE

- 2.1. Scope of work: Andhra Pradesh Grameena Bank invites sealed applications for Empanelment of contractors for Interior Furnishing & Carpenter Works, Electrical & LAN works, Architectural Services and Printing & Stationery works at Branches/Offices/ATMs. The bids will be assessed on the terms and conditions mentioned in this document. Qualified bidders will be empaneled under the bank for 3 years duration and will be used for carrying out Interior Furnishing & Carpenter Works, Electrical & LAN works, Architectural Services and Printing & Stationery works in branches/ATMs/Offices.
- 2.2. Sealed Applications are invited by The General Manager, Services Department, Head Office, Guntur, 4th Floor, Raghu Mansion 4/1 TH Lane, Opp Hotel Sankar Vilas Brodipet, Guntur 522 002.
- 2.3. The contractors shall be empaneled for Andhra Pradesh Grameena Bank for duration of 3 years from the date of completion of process and will be informed through empanelment letter from the bank.
- 2.4. The Empaneled contractors will be participating in Tenders/quotations for works as and when required by the bank. Closed tenders will be asked from contractors through publication of Tenders on Bank's website or by asking quotations for which the decision of Bank will be final. In case the empaneled contractors do not participate in 3 successive tender processes, their empanelment with the bank may be summarily rejected.
- 2.5. Merely participating in Empanelment process or getting empaneled under Andhra Pradesh Grameena Bank does not qualify the contractor to claim work. All rights in this regard will be on the discretion of the bank.
- 2.6. The Firms are required to complete the application form as per format given in this document and sign on each page of application before submission. Supporting documents in respect of all points mentioned in application form should be submitted in technical bid. The complete set is to be enclosed in sealed envelope addressing to:

- 2.7. The Tenders shall be submitted by 05.00 PM on 04-08-2025.
- 2.8. The Tender is to be submitted in <u>a sealed Envelopes</u> super scribing with 'Application for Empanelment of Contractors for Interior Furnishing & Carpenter Works/ Electrical & LAN works/Architectural Services/Printing and Stationery works (strike out whichever is not applicable) at Branches/ ATMs/ Offices'.
- 2.9. Tender document should contain complete application form with all the relevant information (Bio-data, General conditions, warranty clause, detailed terms & conditions, feedback forms and copy of work orders in support of experience, duly signed on each page along with cost of the Tender Document). No information regarding price is to be given in Technical bid.
- 2.10. <u>Tenders without Pay Order/ Demand Draft shall be summarily rejected</u>. In case of bidders are registered with NSIC/MSME, they are eligible for waiver of Tender document cost, However, they need to provide valid NSIC/MSME Certificate clearly mentioning that they are registered with NSIC/MSME under single point registration scheme. For claiming relaxation under NSIC/MSME category, bidders must produce original NSIC/MSME registration certificate at the time of opening of Technical bids.
- 2.11. No Tender will be received after the expiry of the time & date notified for receiving tenders, under any circumstances whatsoever.
- 2.12. The Tender will be opened at 11:00 AM on 05-08-2025 at above address in the presence of authorized representative of contracting agency. No separate intimation/ correspondence will be sent in this regard.
- 2.13. The Tender shall remain valid for acceptance for a period of 180 days from the notified last date of Tender submission.
- 2.14. The Bank reserves the right to accept / reject the lower or any or all tender received at any point of time without assigning any reasons thereof.
- 2.15. Bank reserves all the right to shortlist the contractors based on their feedback from Clients of bidder, quality, quantity, period in business, infrastructure, supervision, locations, business, after sales etc. The Bank reserves the right to empanel/shortlist top rated/scoring one or more vendors at Banks' discretion. At any point of time if the services of the contractor are found unsatisfactory, Bank reserves all rights to de-empanel the contractor. No request in this regard will be entertained under any circumstances.
- 2.16. All Tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
- 2.17. This Tender Notice shall form part of the contract documents.
- 2.18. Selection of contractors will be based on the ability and competence required for good quality jobs to be performed by them.

- 2.19. If the space provided in the Performa is insufficient for giving full details, the same may be given on a separate sheet of paper. All columns must mandatorily be filled by the agency seeking empanelment.
- 2.20. Decision of the Andhra Pradesh Grameena Bank regarding selection of contractors for empanelment will be final and no binding whatsoever and no further correspondence will be entertained. Contractors empaneled will be informed by post/email.
- 2.21. Intending contractors are requested to read carefully before filling the particulars in the Performa.
- 2.22. Information / details furnished by selected party, if found to be false at any time in future or any information affecting empanelment is willingly / unwillingly withheld, if come to the notice of the Bank at any point of time, the bidder's empanelment can be cancelled immediately.
- 2.23. Where copies are required to be furnished, these should be self-certified copies.
- 2.24. Application form is non-transferable.

#### 3. ELIGIBILITY CRITERIA FOR SHORT-LISTING: -

For Empanelment of contractors, following criteria shall be applied. Applicants shall submit proof of documents along with the Tender. Vendors not submitting proof documents and/or not conforming to any of these parameters will not qualify for empanelment.

#### GENERAL CRITERIA & DOCUMENTS TO BE SUBMITTED

- 3.1. Contractor applying for empanelment must be either registered companies or registered partnership firms or Registered Proprietorship firm (*Proof to be attached*).
- 3.2. Firm/Company should be in the business (for the work applied for) for not less than 2 years. Working experience of individual/ proprietor as an employee with other firm shall not be considered valid for counting of total work experience. Working experience will be counted in the work for which empanelment is sought. Working experience in another work will not be considered valid for counting of total work experience. Work experience will be calculated on the basis of registration certificate submitted as per para 3.1 and Empanelment letter/Work Order/Work Completion certificate issued by any Bank/Government organization/PSU.
- 3.3. Firm should be empaneled and providing services to at least one bank/ Government organization/PSU for at least 2 years. Empanelment letter & Work order for the concerned work (for which empanelment is sought) should be submitted along with Tender document for verification of the same. If empanelment letter is not available for a particular organization, 2 work orders (for work order more than 2 lacs each) for each year for 2 consecutive years from same organization will be considered as the firm was empanelled with that organization.

- 3.4. Work satisfactory certificate issued by any bank/ Government organization/PSU where the contractor is already empaneled and successfully completed work orders.
- 3.5. Applicants for Architectural services should be registered with Council of Architects and proof of the same should be enclosed with the application
- 3.6. Bank does not compromise on quality of products and expect good quality product and material to be used by the contractor. If any adverse feedback is received by bank, Bank reserves all rights to de-empanel the contractor from Empaneled list. All products supplied to bank should be supplied under warranty clause and the contractor will be liable for any defects arising in Warranty period at own cost.
- 3.7. Firms should have Income Tax PAN and GST certificate. (Attested copies of PAN card and GST certificate.)
- 3.8. The bidder should have at least one of its operational registered office in AP as on date of RFP. (Submit valid proof of office address (telephone bill/registered rent agreement/ownership document on the name of firm only).
- 3.9. Firms shall not be owned or controlled by any director or officer/employee of the bank or their relatives having the same meaning as assigned under section 6 of the Companies Act 1956. (A certificate denying the ownership of Agency/Firm/Manufacturer / Dealer by any director or officer/employee of the bank or their relatives having the same meaning as assigned under section 6 of the Companies Act 1956 issued by the CEO or Director of the Firm to be submitted along with the tender).
- 3.10. Firms should submit an undertaking (on their letter head) that they have not been blacklisted by any of the Govt. Authority or PSUs/Banks duly signed by authorized signatory with company seal. If at any later stage it comes to the notice of Bank that the firm is blacklisted by any of the Govt. Authority or PSUs/Banks, the contract with the firm will be terminated.
- 3.11. Firms should have registration number for payment of Goods and service tax (GST) and their GST return should have been filed till last quarter (copy of GST return to be enclosed). Firms having invalid GST number or cancelled GST number or inactive GST number will be rejected. (copy of GST registration is to be submitted)
- 3.12. Firm should have made net operating profit for past two years (attach audited Balance sheet of last 2 years Financial years). In case the firm is not under audit then they should submit ITRs along with computation sheets certified by CA & Proof of Payment of tax (Copy of Challan etc.)
- 3.13. Years means financial year unless stated otherwise.
- 3.14. Bids/RFP which are not in sealed covers will not be accepted.
- 4. The bid shall contain no erasures or over writing except as necessary to correct errors

made by the bidder, in which case such corrections shall be authorized by the person or persons signing the bid. <u>Complete bid along with all the required proofs should be handed over in sealed cover</u>, as mentioned to:

#### 5. EVALUATION CRITERIA

- 5.1. Firm shall submit letter of undertaking/declaration on company letter head as per Annexure 2 of this document.
- 5.2. Firm shall submit detailed bio data of the firm as per Annexure 1 (as applicable) of this document).
- 5.3. The Technical bid must be submitted in an organized, numbered (on each page) and structured manner (spiral binding will be appreciated). Each page should be signed and stamped by the authorized official. No brochures/leaflets etc. should be submitted in loose form.

## 5.4. <u>Bank reserves the right to reject an offer under any of the following</u> circumstances:

- 5.4.1. **Document/RFP cost ₹1,000.00** is not submitted (MSME/NSIC bidders may be exempted subject to furnished attached documents).
- 5.4.2. Offer is incomplete and/or not accompanied by all stipulated documents (with attestation wherever required)
- 5.4.3. Offer is not in conformity with the terms and conditions stipulated in this tender document.
- 5.4.4. Specifications stipulated in RFP are not met with. However, deviations resulting in higher/superior configuration will be accepted.
- 5.4.5. Or if found that the information provided in the offer is bogus/False.
- 5.4.6. Declarations as per Annexure 2 is not submitted.
- 5.4.7. Declaration that the Firm is not blacklisted by any Govt. Authority or PSUs/Banks duly signed by authorized signatory with company seal as per Annexure 3 is not submitted.
- 5.4.8. Poor feedback by empaneling agencies (Clients of bidder) even if one client gives poor feedback, the bidder may be not considered.
- 5.4.9. Self-Attested Photocopies of relevant documents / certificates as proof in support of various information submitted in aforesaid annexure and other claims made by the vendor. If the number of vendors qualifying the eligibility criteria of bank as per this document is less than 5, bank reserves all rights to relax the eligibility conditions.

#### 6. EVALUATION PROCESS

Offers (Tenders) will be evaluated in the following stages:

#### 6.1. Stage I

Opening of bids by Tender opening committee as per date mentioned in this document in the presence of Bidders/Representatives of bidders.

#### 6.2. Stage II

Incomplete Offers, i.e., offers not accompanied with Tender cost shall be rejected.

#### 6.3. Stage III

Bids will be evaluated against the stipulated minimum eligibility criteria based purely on valid proof documents submitted by the Contractors. Offers not complying with the eligibility criteria will be rejected.

#### 6.4. Stage IV

Short-listing of firms based on proof of documents submitted, site visits by the Bank's officials and satisfactory feedback from reference sites.

#### 6.5. Stage V

Issue of Empanelment letters to all successful firms up to this stage.

#### 7. TERMINATION FOR INSOLVENCY:

The Bank may at any time terminate the empanelment by giving written notice to the Bidder, if the Bidder becomes bankrupt or otherwise insolvent. In this event, termination will be without any compensation to the Bidder.

#### 8. GOVERNING LAW AND DISPUTES:

- 8.1. The provisions of this tender shall always be subject to government notifications, any rules/ guidelines that may be in force from time to time.
- 8.2. All disputes or differences whatsoever arising between the parties out of or in relation to the construction, meaning and operation or effect of these tender documents or breach thereof shall be settled amicably. However, if the parties are not able to solve them amicably, the same shall be referred to the sole arbitrator mutually agreed by the parties. The arbitration shall be conducted in accordance with the provisions of the Arbitration and Conciliations Act, 1996 (26 of 1996) or any statutory modifications or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceedings under this clause. The award of the arbitrator shall be final and binding on the parties. The fees, if any, of the arbitrator shall, if required to be paid before the award is made

and published, be paid half and half by each of the parties. The cost of the reference and of the award (including the fees, if any, of the arbitrator) shall be in the discretion of the arbitrator who may direct to any by whom and in what manner, such costs or any part thereof shall be paid and fix or settle the amount of costs to be so paid.

- 8.3. During the arbitration proceedings the contractor shall continue to work under the contract unless otherwise directed in writing by the bank or unless the matter is such that the work cannot possibly be continued until the decision of the arbitrator is obtained.
- 8.4. The venue of the arbitration shall be Head office, Guntur.
